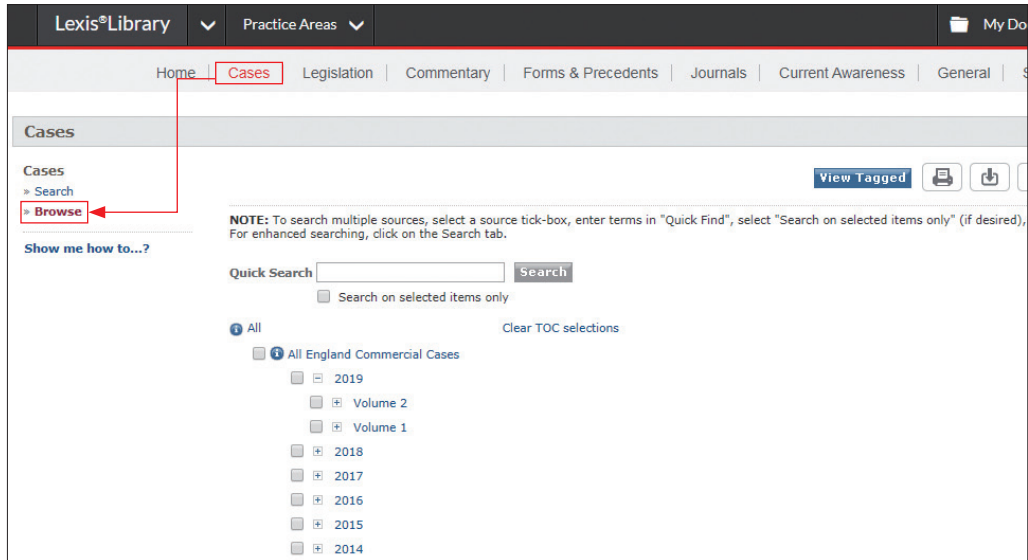

Limitation of action – Period of limitation – Carriage by sea – Claim for damages arising out of death of passenger – Claim brought on behalf of passenger's child more than two years after event but within three years – Whether claim time-barred – Whether domestic legislation suspending limitation period – Meaning of 'suspension' – Prescription and Limitation (Scotland) Act 1973, s 18 – Merchant Shipping Act 1995, s 183, Sch 6, Pt 1, art 16.

Article 16^a of the Athens Convention relating to the Carriage of Passengers and their Luggage by Sea 1974 ('the Athens Convention'), which had force of law in the United Kingdom pursuant to s 183 of the Merchant Shipping Act 1995, provided that any action for damages arising out of the death of a passenger occurring during carriage at sea would be time barred after a limitation period of two years, calculated from the date when the passenger should have disembarked. However, art 16(3) provided that the law of the court seized of the case governed the 'grounds of suspension and interruption of limitation periods', but that in no case could an action under the Convention be brought after the expiration of a period of three years from the date when the disembarkation should have taken place. Residence qualification—Person applying for certificate required to 'reside' in United Kingdom—Applicant owning house in United Kingdom but not entitled to occupy it—Applicant stationed overseas—*Firearms Act 1968, s 26(1)*. **Burditt v Joslin** [1981] 3 All ER 203, QBD.

Exemption—

Air weapon—Gas-powered gun—Whether gas-powered gun an 'air weapon'—*Firearms Act 1968, s 1(3)*. **R v Thorpe** [1987] 2 All ER 108, CA.

Antique firearm—Antique—Firearms less than 100 years old and capable of being used or rendered fit for use—Firearms kept by collector as curiosity or ornament—No intention of using firearms—Whether open to justices to find that firearms 'antique'—*Firearms Act 1968, s 58(2)*. **Richards v Curwen** [1977] 3 All ER 426, QBD.

Antique firearm—Belief of accused—Firearm not antique but a modern reproduction—Accused believing firearm to be antique—Whether accused exempt from requirements to have a certificate—*Firearms Act 1968, s 58(2)*. **R v Howells** [1977] 3 All ER 417, CA.

Shot gun—Smooth-bore gun with barrel not less than 24 inches in length—Rifle altered by removing rifling from barrel—Rifle still capable of firing ammunition originally appropriate for it—Rifle less accurate but still a lethal weapon—Whether rifle as altered a 'shot gun'—*Firearms Act 1968, s 1(3) (a)*. **Creaser v Tunncliffe** [1978] 1 All ER 569, QBD.
